Through November 1, 2020 (542 trials) (50 states, DC, Puerto Rico and Virgin Islands); (Approximately 71 dismissals, mistrials, acquittals or reversals on appeal for conviction rate of approximately 86%, conviction for all murder cases is 70% according to Bureau of Justice Statistics); (Approximately 31 death penalty cases); (91% of cases involve male defendants with 58% of the victims being female); (at least 52% (268 cases) were domestic violence cases, generally a man killing a woman); (17% (90 cases) had victims under 18 years old, generally children of defendants)¹

For three cases of alleged “innocent” men being convicted see Boorn, Jesse (also oldest case), Louise Butler/George Yelder and Hudspeth, Andrew. Also, a case handled by Abe Lincoln: Traylor brothers.

They dumped body in trash bin in NYC. Threesome found in Texas due to GPS in victim's car. 16 yo and wife testified against Adamson. Case upheld on appeal with exception of witness elimination murder count.
Abdur Rashid Al-Wadud	Yolanda Panek, GF and mother of defendant's child	March 1996	Portland, OR	Defendant convicted for July 1995 murder. Evidence included blood found in hotel room where victim was registered, and defendant made 911 call from area after denying being in area.
Aker, Nic/Rick Clappsy	Mary Alice Stephens, GF	April 2003	Bernalillo, NM	Victim had brief relationship with Clappsy but relationship ended. Defendants robbed victim, taking her ATM card and straggling her. Threw body into dumpster. Aker plead guilty and got 60 years while Clappsy was found guilty and got 75 years.
Alcantara, John	Robert Bennett, boss	March 2008	Whittier, CA	Convicted of Feb. 1983 murder of his sanitation crew boss. John Lewin was prosecutor.

Allen, Ron/Ashanti McAllister/Billy Griffin	Evon Young	June 2013/2014	Milwaukee, WI	Defendants convicted at separate trials in gang-related killing of aspiring rapper. Fellow gang members testified that victim was strangled and then shot to death. Griffin's trial ended in a mistrial but he later plead guilty. Allen and McAllister sentenced to life.
Almond, Charles	Richard "Petey" Miller, Jr, fiancée of stepdaughter	March 2016	Augusta County, VA	In 1983, defendant killed stepdaughter's fiancée who accused him of sexually abusing the stepdaughter. Defendant faked a car break down and lured victim to scene. Defendant later confessed murder to numerous people.
Alviso, Jose Maria and Pacheco	John Ruhland	1879	Monterey County, CA	Two brothers killed victim and stole his sheep. They burned body on a fire.

Anderson, Richard	Robert Grantham	Feb. 1988	Hillsborough County, FL	Def tricked victim into thinking he was going to have sex with def's girlfriend, shot him and dumped body in woods, convicted of murder and sentenced to death, committed another no body murder in Pinellas County, FL. Defendant's girlfriend testified against him.
Anderson, Robert	Margaret Armstrong	May 1999	Eureka, CA	Def murdered victim in 1994 who he believed had molested one of his codefendant's child and another child. Buried her after murder. Convicted of first degree murder but claimed he committed crime under duress. California Supreme Court rejected defense.
Andersen, Terry	Douglas Churchill	1998	Council Bluffs, Iowa	Convicted of dismembering and throwing body into Missouri River.

Defendant tried again and convicted in August 2012 but died of natural causes on death row in December 2012.
Archer, John Peter and Victor Baserga	John Pate	Feb. 1997/Sept. 2002	Claremont, CA	Defendants both convicted of murdering victim and cutting off his hands and head. Archer's conviction reversed on appeal but both men retried and found guilty again. Body found in 1994 and in 1995 Baserga led police to location where remains were found.

When it was later proven that that testimony could not be true, second trial ensued at which both defendants were acquitted. Austin, Harold	Marion Fye, girlfriend	Jan. 2006	Washington, DC	Def convicted of murder and given 42 years, prosecuted by Thomas A. (Tad) DiBiase, The No Body Guy. Five children (including three of Fye's children) heard murder and testified against defendant. Victim's blood found on her mattress and defendant confessed to struggling with victim over gun when it went off and killed her. Defendant died in prison.

Barker, Harold	Shelly Turner, fiancé	2009	Montgomery County, OH	Defendant found guilty of September 2006 murder. Case upheld on appeal.
Barnes, Michael	Dawn Pietz, GF and mother of defendant's son	January 1999	Placerville, CA	Defendant convicted of second degree murder, killed victim and put in trunk, 5 years after trial skull of victim found in hills in San Mateo County. Defendant killed himself in prison. Patricia Kelleher was prosecutor.

I worked on this case as well. DC's third no body trial ever.
Barrow, Mark	Rae Meichelle Tener	August 2007	Palm Beach County, FL	Found guilty of August 24, 2004 murder of his neighbor. Defendant confessed to ex-girlfriend and victim's blood was found in his van. Case was reversed for new trial by appellate court in 2010 for trial court's failure to permit read backs to jury and Florida Supreme Court affirmed the reversal in 2012. Retried in 2018, convicted and sentenced to life.
Basham, Branden and Fulks, Chadrick	Samantha Burns/Alice Donovan	2004	Conway, SC	Defendants received death penalty in federal sentencing, Donovan was kidnapped from Wal-Mart parking lot. Donovan's remains found in 2009 near NC border, 15 miles from where she was abducted, after one defendant confessed. Burns body was never found.

Bechler, Eric	Peggye Bechler, wife	March 2001	Orange County, CA	Threw wife off boat on July 6, 1997, convicted and given life without possibility of parole, Debora Lloyd, prosecutor
Beckett, Jr., Robert Wayne and Beckett, Sr., Robert Wayne	Tracy Lea Stewart	Aug., 1989 and Aug., 1995	Los Angeles, CA	Beckett, Jr. was convicted for Stewart's murder in 1989 and sentenced to life in prison. Beckett, Sr. was convicted in 1995 for first-degree murder and sentenced to 25 years to life in prison.

Bennett, Timothy	Mary Jo Bennett, wife	12/13/ 1974	Merced, CA	Murdered on 10/18/72, case reversed on appeal due to Miranda issue, California v. Bennett, 58 Cal. App. 3d 230 (1976)
Bigham, Christopher	Lora Gabbert, girlfriend	April, 1999	Pecos, Texas	Convicted of December 1, 1997 murder, burned victim in barrel and threw pieces into Pecos River, two human toe bones found.

Bondurant, Kenneth Patterson (Pat) and Hugh Peter (twins)	Gwen Dugger	March 1991	Giles CountyTennessee	Twins convicted of 1986 brutal rape and murder of Dugger. Pat was also convicted of murdering and burning fellow Pulaski Rubber Co. employee Ronnie Gaines in 1986. Pat with the help of his brother beat Gaines with a rocking chair. His trial on that matter was reversed twice. The body in that case was found dismembered and burned. Case upheld on appeal, 2008 WL 5510328.

McFarland, posits that the "victim" was actually an imposter. This is also the oldest nobody murder trial I have found.
Bradley, James	Shannon Rippy Van Newkirk	June 2017	New Hanover County, NC	Defendant convicted of April 5, 2014 murder of his co-worker. Sentenced to 30 to 37.5 years in prison. Phone records showed defendant and victim were together at the time of her disappearance.
Brasic, Nicholas Paul	Christine Marie Honson	July, 1986	Kent County, MI	Defendant raped and murdered victim in back of van, convicted of felony murder.
Breeze, Gary	Majorie Ann Cain, ex-wife	1993	Navy Point, FL	Victim disappeared on May 11, 1990. Defendant told numerous people he had killed her and would not be convicted due to lack of body. Defendant was convicted of second degree murder and given 40 years.

Brooks, Richard Wayne	Mark Hatmaker	March 2018	Annapolis, MD	Defendant found guilty for murder related to drug deal and theft of \$40,000. Forensic evidence showed large loss of blood in victim's RV.

In 1990 an appeal reversed his conviction of aggravated murder, and affirmed his convictions of felony murder, burglary, and kidnapping. His new sentence was life in prison without parole. He died in prison in 2001.
Brown, Nettie	T.H. Brown, husband	1909	Oklahoma	Wife, who was sleeping with her stepson, murdered her husband in April of 1909. Stepson, Pete Brown, testified against defendant. From "Dreams of Ada" by Robert Mayer
Brown, William, David Baker, George Mattews, and William Webster	Walter A. Nicoll, master of schooner Sarah Lavinia	December 1843	"High seas"	Murder of ship's mate on high seas on July 14 or 15, 1843

Bulger, Whitey	James Sousa	August 2012	Boston, Mass.	Defendant was long time mob leader in Boston. Tried for 19 murders and found guilty of 11 but not Sousa's. Sousa was killed in October of 1974 when the Winter Hill Gang thought he was going to snitch on them to the police. Victim was shot and then buried in woods off of Route 95.
Busacca, Thomas F	Florence Busacca, wife	March 1977	Mineola, NY	Defendant was convicted of murdering his wife on August 29, 1976. Defense contended she was still alive and put forth witness who said he had lunch with months after she disappeared. Defendant admitted beating her but said he left her alive.
Burns, Thomas E.	Marie Coleman, girlfriend	April, 1961	Philadelphia, PA	Convicted of January 10, 1959 murder
Bush, David	Lynn Lynette Bush, wife	March, 2007	Natrona County, Wyoming	Defendant found guilty for December 1990 murder of his wife.

Defendants were accused of beating and dismembering victim because Butler suspected Yelder had an affair with victim, her niece. Although Butler confessed (and later recanted) the main evidence was testified to by Butler's two young children and another niece. One month after their conviction, the "victim" was found living one county over. Both defendants, who were Black and convicted by an all White jury, were pardoned by the governor. The children admitted they had made the stories up at the behest of another man who had a grudge against Yelder.

Campbell, John	baby daughter	1894	Hamilton County, IL	Convicted reversed due to insufficient evidence since only evidence was word of defendant's mistress who had baby.

Capone, Charles	Rachel Anderson, wife	Sept. 2014	Moscow, Idaho	Defendant found guilty of murdering his wife on April 16, 2010 at his auto repair shop in Moscow. According to testimony, she was strangled, and her body was wrapped in a tarp and driven to the Lewis-Clark Valley where she disposed of off of the Red Wolf Crossing Bridge.

Victim's mother believes she is still alive and was kidnapped by Oregon cult
